2. **Presentation-Budget Cycle Update- Joel Bradburne, DOE**

<i>Question/Comment:</i>	<i>Answer:</i>
Henderson: The selling of the Uranium is fine, until the government says we cannot barter anymore.	Simonton: We will run out of uranium at some point. Bradburne: Our budget is good through March on the Continuing Resolutions. If the Sequestration is implemented that could involve cuts for us.
Roberts: What is the life of the uranium at the rate you are selling it now?	Bradburne: We have enough to last until 2018 at this rate of bartering.

<p>Some SSAB boards send out several recommendations in the first part of the year knowing there will be a turnover, and then they send out a welcoming letter to the new administration listing the recommendations they have submitted.</p>	
<p>Cosby: Where is the uranium being sold from?</p>	<p>Bradburne: From the stockpile here leftover from when we were running uranium. We ship the cylinders to New Mexico to be enriched.</p>
<p>Snyder: With the current baseline for budgets, the D&D will be completed in 2024?</p> <p>We could look at a realistic budget and the current budget and come up with a recommendation.</p>	<p>Bradburne: That is if nothing happens, if things change then it would not be complete in 2024.</p> <p>Simonton: The more we rely on bartering the quicker the uranium will disappear. Joel, Vince and Bill worked hard on getting that approved. If not, we would not have the bartering to make up the budget short fall. Leveled funding would be a great start.</p> <p>Bradburne: We are on a year-by-year budget. Everything works two years ahead.</p>
<p>Craft: Could you look at other board recommendations and see what we can capture from them? I would like to see this subcommittee help with the budgets in any way we can.</p>	<p>Roberts: We can look at the recommendations.</p>
