1. Future Reindustrialization Recommendation Discussion:

Question/Comment:	Answer:
<p>Halstead: Everyone here was at the previous Waste Disposition (WD) subcommittee meeting. You heard recommendation 12-03 that the WD subcommittee has been working on. At our last meeting, it was decided that I would work on a recommendation regarding the waste disposition alternative. My portion was rolled into recommendation 12-03. One of the most important parts of the</p>	

<p>recommendation is that everyone wants jobs. Jobs are the only thing that will help this area, even with the trouble in Japan with the nuclear power plant. The community still says they want nuclear.</p>	
<p>Roberts: The ECLP subcommittee has talked in past meetings about writing a recommendation on the end state, using the FFE plan. What would you like to see in this recommendation? Let us make a list on the flip chart of the key points, and we can send someone home with the list to start writing a recommendation.</p> <p>Who wants to take a crack at writing this recommendation?</p>	<p>Halstead: The number one thing is jobs. There was a very good article in the Portsmouth Times today. State Representative Terry Johnson said the plant site was the key to future jobs in the area. He was talking about the infrastructure.</p> <p>Francis: I would love to see us have a government liaison. Government jobs are the key.</p> <p>Manson: Oak Ridge is building right along with the cleanup. The Canup group said there are businesses interested in coming here, but they would not tell us who the groups are.</p> <p>Henderson: I think it should state in your recommendation that you are using the FFE future vision as your guiding vision. In the opening statement, it should be stated that this recommendation is a starting point.</p> <p>Huber: We need to have a lot more discussion about the green space. The green space needs to be incorporated with the industrial part. Make the space appealing, visually to the eye. Show us the habitat maps. Some area's need saved. Clean up the pond, the space around the cell, make these areas an appealing green space. We need to get the geographic survey maps.</p> <p>I would not mind writing the green space portion. However, I do not feel comfortable writing the whole recommendation.</p> <p>Manson: I would help write the recommendation.</p>
