<p><b>Brushart:</b> Was Piketon High School selected for this project because it is right here?</p> <p>Will the same Piketon High School students continue to work with the ASER next year?</p>	<p><b>Hutzel:</b> We put feelers out and Piketon High School said it would do it.</p> <p>No, next year Waverly High School students will be working on the ASER.</p>
<p><b>Payton:</b> Kids are a great resource. Their thoughts are not clouded by politics.</p>	
<p><b>Bradburne:</b> Does everyone understand what the ASER is? It takes all the environment data and expresses what kind of impact the site has on the community. It is a big deal. It is a real credit to Margaret and the students who pull this all together. These students will know more about the site that most people, including those of us who work there.</p>	
<p><b>Snyder:</b> It is a public document. Does it go to the public library?</p>	<p><b>Roberts:</b> No, the board will get a copy and the EIC library will have a copy, but it is not something the average person would read.</p>
<p><b>Simonton:</b> The ASER Summary came about because of your recommendation on outreach. I am proud of your recommendations. They do make a difference.</p>	<p><b>Roberts:</b> There was a lot of discussion at the National Chairs Meeting. Other sites have had trouble getting students involved. You might want to consider writing a recommendation showing your support of the ASER project to DOE.</p>
